EIGHT STATES WITH ONLY ONE SHELTER PROGRAM SPECIFICALLY FOR VICTIMS OF TRAFFICKING

BALTIMORE, MD, May 17, 2021

Did you know that there are nine states with no shelter program specifically for victims of trafficking and eight states have only one shelter program? Did you know that your state is one of them? As of April 2021, Institute research has identified nine states that have no shelter program dedicated to victims of exploitation, and eight states have only one shelter program. The states of Delaware, Idaho, Maryland, New Hampshire, New Jersey, North Dakota, Vermont, West Virginia, and Wyoming currently have no shelter program. Lack of housing remains the #1 need reported by law enforcement and frontline victim service agencies.

It's well established: there is a national deficit in housing and restorative care options for victims of sexual exploitation. The Samaritan Women - Institute for Shelter Care (https://instituteforsheltercare.org/) is leading a national initiative to close the gap in services. To address this gap the Institute for Shelter Care created a shelter-planting and mentoring program. Based on our research and anecdotal evidence, the most common areas of shelter closure include: (1) staffing, (2) financial stability, (3) lack of program, and (4) leadership. We can do something about these challenges. This program includes one full-year of on-site and online training in nonprofit management, leadership, fundraising, legal and HR, as well as service-specific training on victimology, trauma-informed care, addiction support, crisis and therapeutic interventions, and our proprietary Care Model. The training year is followed by a 2-year mentorship designed to increase stability and effectiveness.

The 2021 cohort of start-up agencies includes start-up shelters in MD, TX, IN, MS, VA, KS, DE and KY. "Being a part of the mentorship program with the Institute has been a pure honor, as we have learned from the best in the field," notes Kay Duffield, Executive Director of Reset 180, a member of the 2019 cohort who currently operates a drop-in center and is opening a shelter. "We have been given the tools we need to work toward opening a residential program," comments Duffield.

The application process is now open for the 2022 cohort. Up to 8 start-up agencies will be selected from across the nation. "Training and mentoring these agencies to do this very difficult work requires a significant investment of time and resources, but the social cost of doing nothing is far greater," comments Jeanne L. Allert, Executive Director of The Samaritan Women. The Samaritan Women - Institute for Shelter Care is dedicated to building the national landscape of victim services so that *any survivor*, *anywhere in the nation*, *would have access to compassionate*, *qualified care*.
